1. DESCRIPTION OF COPY TRADING SERVICES

By subscribing to Copy Trading Service the User may assess selected trader(s) performance, follow the selected trader's activities, copy the selected trader's trading strategies, and view selected trader's history, rankings, risk profile and other information relating to the trader's performance. ("Copy Trading Service").

2. AGREEMENT AND ACCEPTANCE OF TERMS

By accessing the Copy Trading Service from <https://bitmax.io> (the "**Platform**") via desktop or mobile application, you acknowledge and agree that you have reviewed this Disclaimer, in conjunction with both the Platform's Terms of Services relating the Copy Trading Service (<https://bitmax.io/#/terms-of-service>) and Risk Disclaimer relating to the Copy Trading Service (<https://bitmax.io/#/risk>).

The Copy Trading Service subscription currently is set for 30-day period with auto renewal function which can be turned off before the expiration of current term in order to cancel the next subscription.
